

Colman Dock access during construction

Construction update

Key components of Colman Dock are aging and vulnerable to earthquakes and need to be replaced. Crews are currently building the new trestle on the south side of the dock, including a new passenger-only ferry facility. Construction will continue through early 2023. Colman Dock will remain in operation during construction, and no WSF sailings will be cut.

Washington State Ferries access

Drivers

- Enter ferry access lanes from the intersection of Alaskan Way and Madison Street
 - ► For drivers heading southbound on Alaskan Way, right turns may be restricted at Madison Street during peak times
- Northbound left turns at Yesler Way are allowed for trucks over 40 feet, vanpools and motorcycles only
- Vehicle exits remain at Yesler Way or Marion Street

Pick-up and drop-off

- On the west side of Alaskan Way under the viaduct between Marion and Columbia streets
- Inside the ferry queuing area during limited hours, typically:
 - ► Monday through Friday **before** 3 p.m. and **after** 7 p.m.
 - ▶ Saturdays **before** 9 a.m. and **after** 3 p.m.
 - ► Sundays all day


Pedestrians

- Marion Street Bridge from First Avenue is open
- Terminal building, elevator and stairs are open

Bicyclists

 Continue to use bicycle entry just north of Yesler Way

Vehicle, bicycle and pedestrian access



King County Water Taxi and Kitsap Transit Fast Ferry customers

- The passenger-only ferry facility is now temporarily located on the north side of Colman Dock
 - ▶ Passengers enter from Alaskan Way between Madison and Marion streets
- ► A fence and barriers separate walk-on passengers from the WSF vehicle holding area
- The new facility will open on the south side of Colman Dock in fall 2018
