**Introduction**


The Washington State Department of Transportation is pleased to present our legislative report for the 2015-2017 Pedestrian and Bicycle and Safe Routes to School programs.

In addition to providing safer facilities for pedestrians and bicyclists, these two grant programs provide an ideal backdrop to advance several of WSDOT’s strategic goals. The programs provide resources to make strategic investments, advance modal integration and the opportunity for enhanced community engagement through stakeholder collaboration. These grant programs are available to cities, counties, tribal nations, state agencies, and other public agencies to support pedestrian and bicycle projects within their respective communities.

Washington State Department of Transportation, (WSDOT) through a competitive criteria-based process, has identified cost-effective projects and submits this informational report to the legislature.


**Pedestrian and Bicycle Program - Past Performance**

- Since this program was created in 2005, (ESSB 6091) funding requests have consistently exceeded funding amounts provided
- Between 2005 and 2013, over \$44 million was made available to 55 agencies for 103 projects.



\*Note: For the 2011-2013 grant cycle, WSDOT used an invitation process rather than a call for projects.

- 74% of projects awarded in the first four cycles have been completed.
- To date, 66 projects have been completed, 35 are underway, and 2 were cancelled.



## 2015 - 2017 Pedestrian and Bicycle Program Selection Process and Review Criteria

The purpose of this program is to aid public agencies in funding cost-effective projects that reduce bicycle and pedestrian related collisions, and work to increase walking and biking. New to this biennium, design/scoping-only projects were deemed eligible for funding in addition to general construction projects. Design/scoping projects allow project proponents the opportunity to engage with communities and stakeholder groups to create and design better accepted projects appealing to a wider range of users and stakeholders.

All proposals were given an initial review to ensure proposals were complete and met eligibility criteria. All proposals were then reviewed evaluated and ranked by a committee resulting in a preliminary list of prioritized projects. This review committee included representatives from: Association of Washington Cities, Childhood Obesity Prevention Coalition, Wenatchee Valley Transportation Council, Recreation and Conservation Office, WSDOT's Tribal Liaison, and WSDOT Local Programs. Lastly, WSDOT Local Programs conducted site visits with project proponents prior to finalizing the list of prioritized projects.

The following criteria were used to evaluate and rank the project proposals.

- (a) Promoting healthy communities by encouraging walking, bicycling and using public transportation.
- How well will the project improve and/or complete connections that establish safer and fully accessible crossings, sidewalks, trails, bike facilities, and transit connections consistent with peer reviewed, context sensitive solutions guides, reports and publications?

(b) Improving safety by designing major arterials to include features such as wider sidewalks, dedicated bicycle facilities, medians, and pedestrian streetscape features, including trees where appropriate.

- How will the project improve safety, while expanding mobility for all users, especially at-risk populations?

(c) Protecting the environment by providing safe alternatives to single occupancy driving.

- How well will this project support infill, encourage redevelopment and reuse of existing building stock, intensify land uses, and connect housing and employment.

(d) Preserving community character by involving local citizens and stakeholders to participate in planning and design decisions.

- How has or how will this project ensure community engagement in planning and design decisions that will help to preserve community character?

Other consideration was given to the following:

- Project delivery status (planning, environmental review, right of way acquisition, construction plans),
- Overlap with nationally designated Main Street communities, Main Street affiliates, or National Historic Districts that are also community main streets.
- Consistency with community plans
- Consistency with the federal principles of livability (EPA-HUD-DOT partnership) including:
  - Providing more transportation choices
  - Promoting equitable, affordable housing
  - Enhancing economic competitiveness
  - Supporting existing communities
  - Valuing communities and neighborhoods

## **Bicycle and Pedestrian Travel Data**

Administration of a multimodal transportation system requires reliable and current travel data for all modes. Currently available bicycle and pedestrian travel data is not complete. Large gaps in the data limit the State's ability to identify and prioritize bicycle and pedestrian projects for a more efficient transportation system. For this reason, WSDOT Local Programs and the Pedestrian and Bicycle and Safe Routes to School Program Review Committee recommends funding the Permanent Statewide Bike Counter Network Establishment project and the Washington State Student Travel Survey project. These are not typical projects in that they serve a statewide need rather than a local project improvement. The information from these projects is critical to maximize the value of funding spent to improve conditions for walking and biking.





## Safe Routes to School Program - Past Performance

- Since this program was created in 2005, (ESSB 6091) funding requests have consistently exceeded funding amounts provided
- Between 2005 and 2013 approximately \$51 million was made available for 138 projects
- The SRTS bicycle and pedestrian safety education project provided in 41 school districts reaches over 16,000 children in 5th through 8th grades a year.



- 77% of projects awarded in the first four cycles have been completed.
- To date, 74 Safe Routes to School projects are complete, 63 are underway and one was cancelled.



## **2015 - 2017 Safe Routes to School Program Selection Process and Review Criteria**

The purpose of the program is to aid public agencies in funding cost-effective projects that improve safety and increase the number of children walking and biking to school. All projects must be within two-miles of primary, middle or high school (K-12). New to this biennium, projects near high schools were eligible for funding. The program followed a similar review process as the one used in the past to meet the intent of the program.


All proposals were given an initial review to ensure proposals were complete and met eligibility criteria. All proposals were then reviewed, evaluated and ranked by a committee resulting in a preliminary list of prioritized projects. This review committee included representatives from: Association of Washington Cities, Childhood Obesity Prevention Coalition, Wenatchee Valley Transportation Council, Recreation and Conservation Office, WSDOT's Tribal Liaison, and WSDOT Local Programs. Lastly, WSDOT Local Programs conducted site visits with project proponents prior to finalizing the list of prioritized projects.

The following criteria were used to evaluate the project proposals.

- Project Meets Program Goals:
  - Safety - The project reduces potential pedestrian and bicycle conflicts with motor vehicle traffic; targeting improvements to address known collision locations.
  - Access and Mobility – The extent to which the project will establish safer and fully accessible crossings, walkways, trails or bikeways and increase the numbers of children walking and biking to school.
- Value/Return on Investment (ROI)
  - The cost of the project compared to the potential impact.
- Applicant Commitment
  - Measured as a percent of match.
- Project Delivery
  - Expedient completion of project within biennium including timeliness of preliminary engineering, right of way and project construction
- Equity
  - Project targets schools that serves lower income populations as these populations tend to utilize these facilities more frequently.
