Medina to SR 202: Eastside Transit and HOV Project


Temporary 84th Avenue Northeast road alignment work begins Monday, June 17

Drivers can expect short delays across the lid while crews complete the new alignment which will open Monday, June 24

Beginning Monday, June 17 crews will work during the day and night for one week to complete the new alignment on 84th Avenue Northeast, where it crosses SR 520. The new road alignment over the lid allows crews to complete the roundabout. The new alignment will improve sight distance at the intersection of 84th Avenue Northeast and Northeast 28th Street.

Here are the details of the work:

- **Monday, June 17-24:** Crews will alternate a single lane of traffic across the 84th Avenue Northeast lid day and night for one week.
 - **Lane closure:** One lane of 84th Avenue Northeast across the lid, flaggers will alternate traffic.
 - **Ramp closure:** The eastbound off-ramp to 84th Avenue Northeast will be closed from 9 p.m. Friday, June 21 to 5 a.m. Monday, June 24. A detour route will be posted.
 - **Nighttime noise:** Residents may hear construction machinery from crews paving, striping and setting barrier along 84th Avenue Northeast across the lid.
- **Monday, June 24:** Crews will open the new 84th Avenue Northeast road alignment over SR 520.

Next steps: Crews will open the on-ramp to westbound SR 520 later this summer. The roundabout configuration will open later this fall.

This work is weather dependent and the construction schedule is subject to change.
