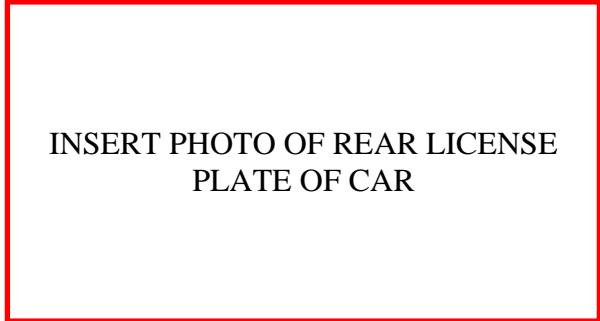

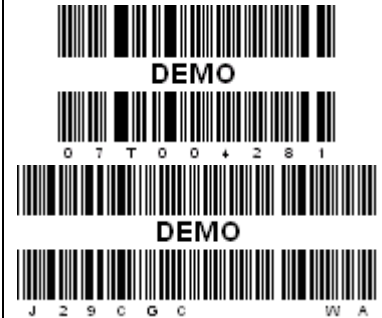
**YOU MUST RESPOND WITHIN FIFTEEN (15) DAYS FROM THE DATE ISSUED.**

**Your response must be postmarked by midnight of the date it is due at the court.**

**If you do not respond or appear for court hearings:**

1. The court will find that you committed the infraction.
2. Your penalty will be increased.
3. Failure to pay may result in a referral of your case to a collection agency.

**Failure to respond or pay may affect your ability to renew your vehicle license.**



If your vehicle was stolen or otherwise not in your care, custody, or control at the time of the violation, you may submit a sworn statement to that effect to the Court to rebut the presumption established in RCW 46.53.075 that you were driving the vehicle at the time of the violation. A Declaration of Non-Responsibility form can be obtained from the court in one of the following ways:
