



## Regional Rail Workshop Monday, September 30, 2013 ~ Centralia, Washington

The Cowlitz-Wahkiakum Council of Governments, Thurston Regional Planning Council and Southwest Washington Regional Transportation Council, in partnership with the Grays Harbor Council of Governments, the Lewis County Transportation Strategy Council and Washington State Department of Transportation, are hosting a public workshop on the **Draft Washington State Rail Plan**. We encourage the public to attend and share ideas regarding passenger and freight rail.

The Washington State Rail Plan will provide an integrated approach for both freight and passenger rail, including 5- and 20-year funding strategies. When complete, the plan will serve as the strategy for future public investment in the state's rail transportation system.

The Centralia meeting will allow for comments to be received in preparation for the release of the plan, scheduled for late 2013. Citizens, elected officials, public agency staff and others are invited to attend and discuss freight and passenger rail transportation for southwest Washington to help refine the statewide rail plan draft. Workshop participants will receive an update on ongoing technical analysis and discuss priority needs and opportunities for the state rail system.
