Removal of bed load material, sediment, and debris from channelized streams within WSDOT’s Right of Way. It also includes repair of washouts (erosion) to WSDOT’s embankments supporting the roadway.

6b. Describe the purpose of the project and why you want or need to perform it. [\[help\]](#)

The maintenance activities will be performed to re-establish the pre-existing flows of channelized streams. Without this activity a channelized stream may loose its capacity to carry water within the channel during storm events, resulting in flooding of the roadway and erosion of the roadway embankment.

Woody debris is repositioned when the material is directing stream flows into the roadway embankment creating washouts of the roadway structure.

The work is maintenance of existing channelized streams. The work involves the removal of bedload material, sediments, woody debris, and other debris. The work is done by hand (such as a shovel) or with equipment (such as a backhoe, vactor truck, pull dozer, and/or crane) depending on the specific site and material to be removed. The material is lifted out of the channel and placed above the OHWL, with the exception of Large Woody Material (LWM) that will either be floated downstream if possible, or picked up and repositioned at another location below the Ordinary High Water Line (OHWL) or along the stream bank.

Repair to embankment areas eroded away will be done by the placement of rip rap, soil, or other acceptable material. Rip rap placement in areas where none previously existed will be limited to the amount needed to stabilize the embankment supporting the roadway infrastructure.

End dumping of rock and LWM below the OHWL will not be allowed. The material will be placed in a controlled manner to reduce potential siltation problems.

The activities are maintenance of existing channelized streams adjacent to, or perpendicular to, WSDOT roadway structures. The work is being performed to restore flows to pre-existing conditions and stop adverse impacts associated with siltation from washouts (erosion of the bank), major reconstruction of the infrastructure caused by erosion, and stranding of fish associated with the water body overtopping its banks.

Impacts to the aquatic system will be minimized by following the Regional Road Maintenance Program part 2 – BMPs. This includes, but not limited to, removing fish from the work area when in-water work is performed, installation of block nets to keep fish from re-entering the work area, the placement of fish screens on the intake hose of water diversion pumps, following WDFW’s *Allowable Freshwater Work Times, May 2010* when applicable and the installation of diversion structures, when appropriate, for working in the dry. WSDOT is requesting that *WSDOT’s Standard Fish Moving Protocol – August 2012* be used when fish

exclusion activities are required.

In addition, BMPs will be used to insure water quality standards are not exceeded by the maintenance activity and that water pumped out of the work, when done, will be not contain sediments when allowed to re-enter waters of the state.

Care will be taken to minimize any damage to native riparian woody species. Plants destroyed by the activity will be replaced at a 1:1 ratio. All areas of bare soils caused by the maintenance activity will be seeded, mulched, or other approved BMP to control erosion of the bank and siltation of the stream.

Bed load and sediments removed from the stream channel will be disposed of in an upland location where the material will not be washed back into the water body or water from the material will not flow directly into the stream without being processed through a BMP to remove silts.

Large woody material that is creating a blockage system, or is eroding the infrastructure, will be removed and repositioned below the OHWL in a location where it will not be impacting the roadway structure. This will insure a no net loss of habitat structures in the stream.
