

SR 99 Tunnel: North Portal Street Restoration


Seattle Tunnel Partners is restoring the roadway surfaces of streets near the closed work zone at the North Portal. This work is expected to last through June 2018 and is an important step toward completing the SR 99 Tunnel Project.

Construction Schedule

Most work will occur during daytime hours, however some nighttime work may be required. Nighttime work may include using electric saws to cut recently poured concrete, which may be loud to project neighbors. During this work, crews will close individual street blocks around-the-clock for approximately one to two weeks at a time. The entire street restoration effort is expected to last up to two months.

Currently scheduled work activities:

- **Monday, May 7, through Saturday, May 12**
7 a.m. - 10 p.m. Monday through Friday
and 9 a.m. - 10 p.m. on Saturday
 - South half of Sixth Avenue North between Thomas and John streets will be closed around the clock.
 - Parking on both sides of Sixth Avenue North will be closed around the clock.
- **Monday, May 14, through Saturday, May 26**
7 a.m. - 10 p.m. Monday through Friday
and 9 a.m. - 10 p.m. on Saturday
 - South half of Taylor Avenue North between Thomas and Harrison streets will be closed around the clock.
 - Single lane closure within the intersection of Taylor Avenue North and Thomas Street. Flaggers will direct traffic during work hours.
 - Parking on both sides of Taylor Avenue North will be closed around the clock.

Some of this work is unavoidably noisy and may be disruptive. Noise levels will vary during this work, but you may hear concrete breaking, trucks, and other noise from heavy construction equipment. Each block will include several days of concrete breaking, as well as one to two days of concrete pours.
