Sealed bids, subject to the conditions contained herein, for improvements to the Methow Valley State Airport, Winthrop, WA, AIP Project no. 3-53-0110-009-2018. **ESTIMATE RANGES PUBLISHED IN THIS NOTICE MUST NOT BE USED AS A BASIS FOR BID PREPARATION.**

The work involved will include the following: Schedule I - West General Aviation Apron Expansion

(\$500,000 to \$1,000,000)

Some of the major bid items involved in the proposed work are: subgrade preparation, aggregate base course, bituminous paving course, modified bituminous binder, and install 6-inch perforated polyethylene underdrain pipe.

Construction for this project is expected to take 35 calendar days.

All bid proposals shall be accompanied by a bid proposal deposit in cash, certified check, cashier's check or surety bond in an amount equal to five percent (5%) of the amount of such bid proposal. Should the successful bidder fail to enter into a contract and furnish a satisfactory performance bond, the bid proposal deposit shall be forfeited. **Bonds submitted on other than the bond form provided by the department may be subject to rejection. The right is reserved to reject any and all bids and to waive informalities in the bidding.** Sealed bids will be received in the Bid Room 2D20, located on the second floor of the Department of Transportation, 310 Maple Park Avenue SE, Olympia, Washington, 98504 until 11:00:59 am Pacific Time, or at P.O. Box 47360, Olympia, Washington, 98504- 7360, until 11:00:59 am Pacific Time, on Wednesday, June 27, 2018.

The successful bidder will be required to furnish separate performance and payment bonds each in an amount equal to 100% of the contract price.

104 WA 98862. Bidders are expected to examine the drawings, specifications, bid documents, proposed
105 contract forms, terms and conditions, and all other instructions and solicitation documents.
106 Bidders are expected to visit the job-site to determine all requirements and conditions that will
107 affect the work. Failure to do so will not relieve a bidder from responsibility to know what is
108 contained in this invitation for bid, or site conditions affecting the work.

110 **Bid Conditions.** The bidder is required to provide all information as required within the Contract
111 Documents. The bidder is required to bid on all items of every schedule or as otherwise detailed
112 in the Instructions to Bidders.

114 Bids may be held by Washington State Department of Transportation (WSDOT) for a period not
115 to exceed 120 calendar days from the date of the bid opening for the purpose of evaluating bids
116 prior to award of contract. This project will be awarded in 2018.

122 **Airport and Airway Improvement Act of 1982 as amended.** In accordance with the Davis-
123 Bacon Act, as amended, the Contractor will be required to comply with the wage and labor
124 requirements and to pay minimum wages in accordance with the schedule of wage rates established

127 **State Wage Rates:** The State of Washington prevailing wage rates are applicable for this public
128 works project located in Okanogan County. Bidders are responsible to verify and use the most recent
129 prevailing wage rates. The "Effective Date" for this project is the Bid Form due date above. The

136 Opportunity Construction Contract specifications including the goals and timetables for minority
137 and female participation.

153 **DBE Requirement.** It is the policy of the Washington State Department of Transportation's

156 their CFR Part 26 program. The goal is not a contractual obligation, however, the Owner encourages
157 efforts by the contractor to achieve this goal. The Owner encourages participation by all firms

160 Contractor shall provide a certified statement signed by the subcontractors, indicating actual
161 amounts paid to the Disadvantaged Business Enterprise (DBE) subcontractors and/or suppliers
162 that were used on the project through race neutral means.

164 **Buy American Preference**

165 The Contractor agrees to comply with 49 USC § 50101, which provides that Federal funds may not
166 be obligated unless all steel and manufactured goods used in AIP funded projects are produced in
167 the United States, unless the Federal Aviation Administration has issued a waiver for the product;
168 the product is listed as an Excepted Article, Material or Supply in Federal Acquisition Regulation
169 subpart 25.108; or is included in the FAA Nationwide Buy American Waivers Issued list.

171 A bidder or offeror must complete and submit the Buy America certification included herein with
172 their bid or offer. The Owner will reject as nonresponsive any bid or offer that does not include a
173 completed Certificate of Buy American Compliance.

175 **Certification Of Offeror/Bidder Regarding Debarment**

176 By submitting a bid/proposal under this solicitation, the bidder or offeror certifies that neither it
177 nor its principals are presently debarred or suspended by any Federal department or agency from
178 participation in this transaction.
