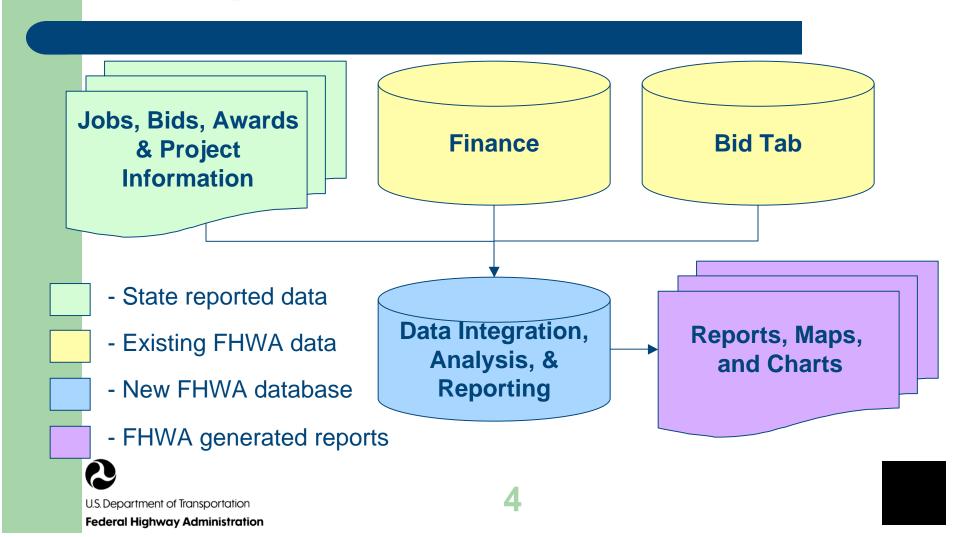


RADS - Recovery Act Data System

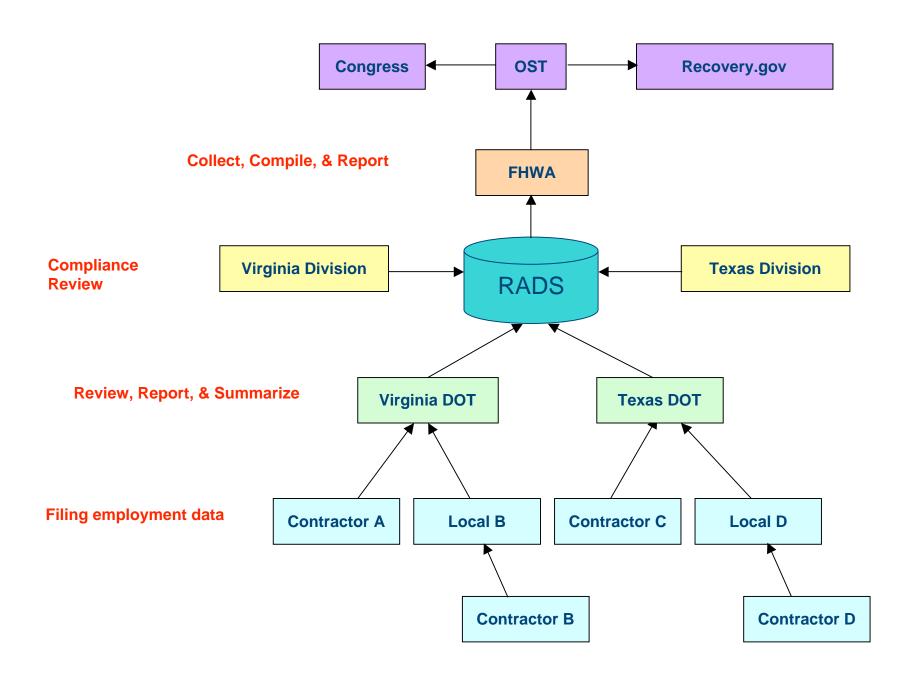
- Used for ARRA related:
