The Bridge and Structure's office is requesting blanket approval to use the following materials statewide for the 20013 – 2015 biennium.

Proprietary Item:

Anvil International

Concrete Insert Figure No. 286

Justification:

No other equally suitable alternative exists. The concrete insert as listed above from Anvil International is currently the only known bridge deck insert that fits a rod diameter greater than 7/8 inches and meets WSDOT Bridge and Structure office's corrosion resistance requirements. The larger diameter rod is required for bridge under-deck utility hanger systems for large diameter utilities such as fourteen inch or larger gas or water lines.

The Public Interest Finding is served by utilizing these concrete inserts:

- Meet WSDOT structural and corrosion requirements.
- Allows utility companies to cross rivers, stream, or roadways by attaching their large diameter pipes, fourteen inches or greater, underneath the bridge decks.
