Construction Draft Environmental Impact Statement Guide

Fact Sheet 5 June 2008

The Columbia River Crossing (CRC) Draft Environmental Impact Statement (EIS) was released May 2, 2008, for a 60-day public comment period. The report describes the:

- Existing conditions of the project area
- Purpose and need of the project
- Five alternatives analyzed
- Expected positive and negative effects of each alternative to community, natural and cultural resources
- Options to avoid, minimize or mitigate negative effects
- Preliminary analysis of costs, financing and cost effectiveness
- Coordination between agencies

Why was the Draft EIS Developed?

A Draft EIS is required by the National Environmental Policy Act (NEPA), the federal law regulating the decision-making process for federally funded projects. The purpose of NEPA is to help ensure that public projects address the needs of the community while avoiding, minimizing or mitigating negative effects on community, natural and cultural resources. NEPA requires agencies that receive federal funding to consider the public's input when a project may affect the community or its natural or cultural resources.

The CRC Draft EIS does not recommend a Locally Preferred Alternative (LPA). The document presents data for the public, project sponsors and stakeholders to consider in recommending an LPA.

The LPA is the alternative selected by local decision-makers as the preferred solution to the project's identified needs. These local decision-makers are:

- Oregon Department of Transportation
- Washington State Department of Transportation
- Southwest Washington Regional Transportation Council
- Metro
- C-TRAN
- TriMet
- City of Vancouver
- City of Portland 🖊



What Happens Next?

The CRC Task Force will consider Draft EIS findings and public input before making a recommendation on an LPA in June 2008. Then, local sponsoring agencies will endorse an LPA by August 2008. The LPA would then be adopted into Metro's Regional Transportation Plan and RTCs Metropolitan Transportation Plan. The CRC LPA will designate a river crossing, transit mode and transit terminus for the project.

Other aspects of the project will be determined after the LPA is selected:

- Financing and tolling plan
- Optimized lane configuration for safety lanes across the river
- Pedestrian and bicycle path elements
- Refined highway, bridge and transit design
- Mitigation plan
- Construction management plan

CRC will continue to seek public input throughout the project development process. The Record of Decision will confirm these decisions in late 2009, after the release of the Final EIS.

Examples of Draft EIS Comments

Example #1

🔶 Tell who you are/why you are interested

I am a supporter of the Historic <u>Trandalour Theater</u>. In the Draft EIS, I notice interchange design options for Meyer Road.

Given the likely impacts to the theater, <u>*I like the interchange design which could*</u> <u>*leave land to replace land lost to the*</u> *expansion of the highway.*

 Identify project details that you like and/or dislike

Example #2

Suggest ways to address your concern

I am a resident of the Blaney Park neighborhood. <u>*I support transit that*</u> *connects to other systems easily.*

I am interested in station comfort. <u>I would like to see design amenities</u> <u>included which protect riders from</u> <u>the elements</u>, like covered waiting areas.

I think pedestrian and bicycle amenities at stations are very important. In particular, <u>enough bicycle parking in</u> <u>good visible locations</u> should be provided.

Provide opinions or preferences on specific impacts and, where possible, use examples or data

Why Comment?

The CRC Draft EIS is a summary of the potential community and environmental effects the five project alternatives are likely to have on the surrounding area. Public review and comments on the report are important to:

- Ensure that community, natural and cultural resources and effects are fully identified and evaluated.
- Help select a preferred alternative and ensure that all reasonable alternatives are properly considered.
- Shape an LPA and identify measures that could be taken to minimize negative effects.

The Columbia River Crossing Draft EIS includes Draft Section 4(f) Evaluation

In addition to NEPA, federal laws also require federallyfunded transportation projects to avoid effecting land that is used as a public park or wildlife refuge or has historic value. Use of the land is allowed if no other realistic option exists or if the effects of using the land are minimal.

Section 4(f) of the Department of Transportation Act (as described in federal regulations Title 23 CFR 774) states that the use of significant historic resources, public parks and recreation facilities, and wildlife refuges can only occur if there is no prudent alternative that would avoid the impacts, or the impacts are *de minimis*. *De minimis* impacts are those that "will not adversely affect the features, attributes or activities qualifying the property for protection under Section 4(f)."

The Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) have proposed that the potential impacts from CRC alternatives to four public parks would qualify as *de minimis* impacts:

- Waterfront Park
- Waterfront Trail
- Leverich Park
- Kiggins Bowl and Trail

Chapter 5 of the project's Draft EIS contains more details about each of these sites.

Draft EIS Comment Period

Public comment period: May 2 to July 1, 2008

The project is seeking public input and review of the Draft EIS and proposed *de minimis* findings, as well as other findings in the Section 4(f) evaluation. All comments received between May 2 and July 1, 2008, are identified as Draft EIS comments and will be formally responded to in the Final EIS, expected in 2009.

Your comment will be considered and responded to in the Final EIS. Comments may be grouped with like comments and may be condensed for clarity.
